## AGREEMENT

As a summer golf member, you are entitled to use all facilities of the Club (*tennis does require an extra fee*), subject to the rules prescribed by the Board of governors of The Country Club at Boca Raton.

Golfers may have guests, (*the same guest, up to twice a month and different individuals as often as you wish*) to a foursome whenever you play.

Membership will commence May 1, 2008 and end October 31, 2008. Summer membership will become effective after a completed application is approved by the Board of Governors.

The Country Club at Boca Raton is a "cashless" Club and all Club charges are due and payable by the 25th of each month. *Dues are subject to tax and are not refundable.*

The food minimum must be used prior to the conclusion of your membership. You will be asked for a copy of a Visa or Master Card upon signing up for membership. If there is any unused food minimum or any other balances due the Club as of December 1, 2008, they will be billed directly to your credit card company.

I understand that if at any time my Club account becomes more than 30 days in arrears, Club privileges may be suspended until the account is brought current.
